- 5 A motion was made by Dale Meszaros to approve Officer Positions. The motion
- 6 was seconded by Barbara Pitts, with all in favor.

- 9 APPROVAL OF OCTOBER 2022 MINUTES

- 12 **FINANCIALS**
- 13 Mr. Dorrill reviewed the District's 11<sup>th</sup> month financials. The District has \$217,000 in
- 14 cash, \$42,500 of that is in the operating account. Heritage Greens payables were only
- 15 \$3.800. The District's reserve account is funded at \$175.000. Total revenue at the end
- of the year is \$226,000. On the expense side the Districts engineering fees were over
- 17 budget with the expenses from the sidewalk permitting project. Slightly overbudget for
- 18 legal advertising. Over budget about 12% on the Envera contract because of updated
- technology. The District will still end the year in a favorable position.
- 20 A MOTION to accept the financials was made by Dale Meszaros, and a second by
- 21 Barbara Pitts, with all in favor.
- 22 MANAGERS REPORT
- 23 **NEW BUSINESS**
- 24 A. Sidewalk Project
- 25 The Districts still has a permit open to continue work on the entrance sidewalk. The
- 26 permit expires in 6 months, and we would like to have the work done by then. Timing is
- 27 not perfect to be building anything. The engineer estimate is \$27,655 but that is
- 28 including all work to be done on the wall.
