A motion was made by Dale Meszaros and seconded Leigh Connor by to allow the chairman to sign the resolution of the board to adopt the final budget of the board for fiscal 2022. A second motion was made by Barbara Pitts and seconded by Teri Hilty to establish the assessment of the budget in amount not to exceed \$231,725. All voted in favor. Assessment is \$440 per unit.

- 11 District received \$2,200 in non-ad valorem taxes due to about 5 homes of non-payment.
- 12 Revenues are fully funded.
- 13 A MOTION to accept the financials was made by John Shelton, and a second by
- 14 Dale Meszaros with all in favor.
- 15 **OLD BUSINESS**
- 16 A. Update on Entry Landscaping Renovation
- 17 Rainy start but the project seems to be on schedule. Dorrill Management has not
- 18 received any call to date. Deposit was paid on their first day on site. We asked the
- 19 contractor to remove addition straggly or dead trees. Some lights got cut and will need
- to be relocated at a later date. Additionally, the flagpole will be moved closer to the nose
- 21 of that median.
- 22 B. Additional Preserve Maintenance
- 23 It was reported that kids cut down some trees/dug a hole in the preserve near Saturnia
- 24 Lakes. We will have to pay to address this illegal cutting. Discussions occurred about
- obtaining signage to inform residents that this is a preserve area.
- The golf course will only be reimbursing the District for the illegal cutting they did in the
- 27 preserve on the south end of the neighborhood.
